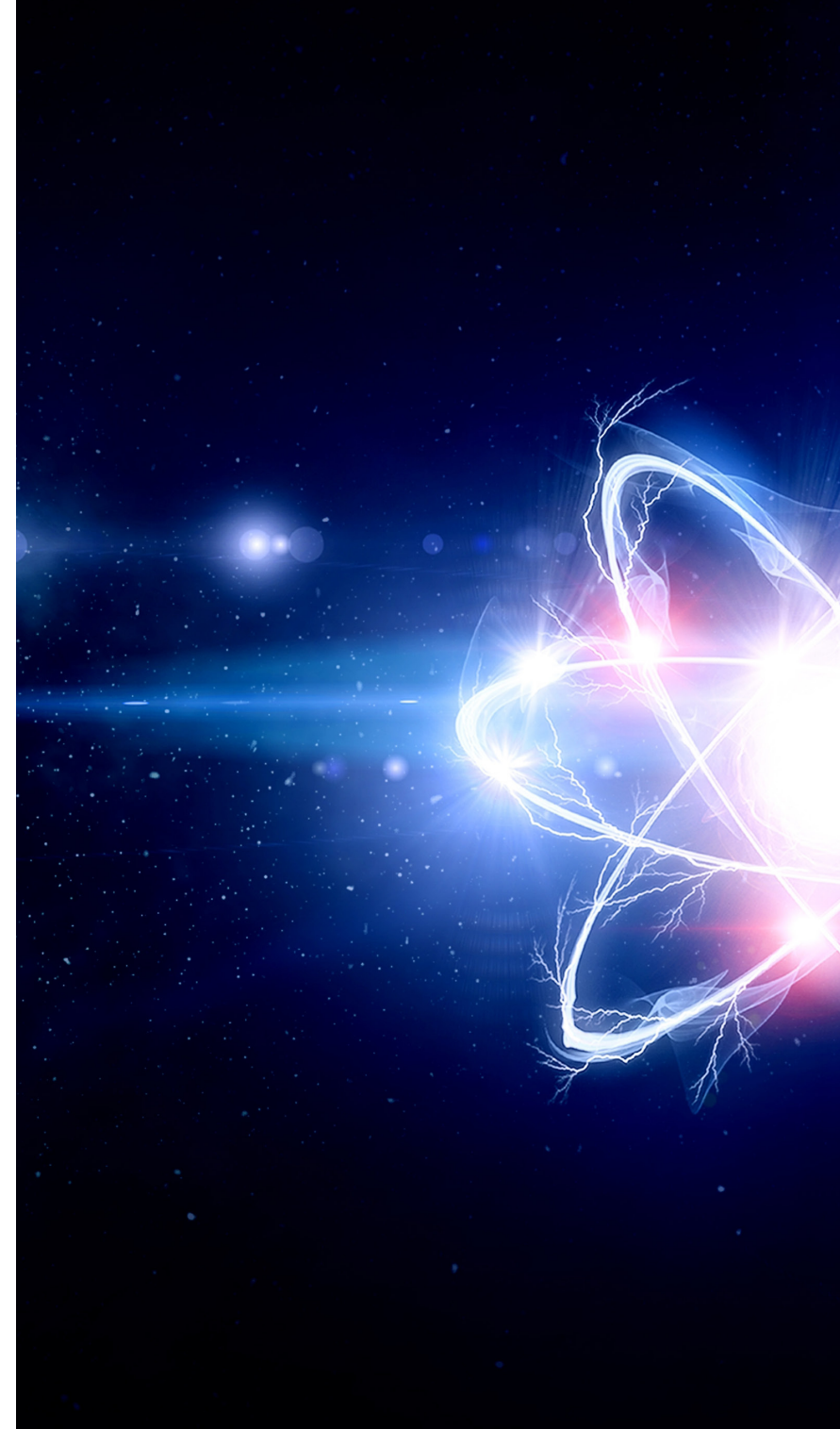
INLA

INLA Next Generation Initiative – Launch at INLA Congress 2026

We are pleased to announce the launch of the Next Generation Initiative at the INLA Congress 2026.

The main objective of the Next Generation Initiative is to create an engagement mechanism for early-career professionals interested in nuclear law within the membership of INLA and to integrate early-career professionals into INLA.

Membership

Membership in the Next Generation Initiative will be open following the launch event at the INLA Congress 2026 and will be open to all early-career professionals with a demonstrable interest in nuclear law. This includes law students, trainees, and qualified lawyers within approximately ten years of post-qualification experience or under 35 years of age.

Individuals will need to be a member of INLA to be able to join the Next Generation Initiative. There will be no additional membership fee to join the Next Generation Initiative.

Essay competition

The title for the essay competition is: **“What Challenges Will the Nuclear Industry and Nuclear Law Face Over the Next 20 Years and How Can the Next Generation Respond?”**.

Essays must be:

- Original work of the author and not previously published.
- Written in English.
- No more than 3,000 words (excluding footnotes)

Submissions should include:

- Author name, affiliation and contact details
- A short abstract (maximum 300 words)

The submission deadline is **1 September 2026**. The winner will be notified by 1 October 2026.
